2. I knowingly and freely assume all such risks, known and unknown, even if arising from the negligence of the Releasees (as defined below) or others and assume full responsibility for my participation; and
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual and significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest employee or volunteer immediately; and
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, indemnify and hold harmless Green Mountain Boys Shooting Club, LLC, Shooting Range, LLC, and their members, employees, other participants, sponsoring agencies, advertisers and, if applicable, owners and lessors of premises used to conduct the event (collectively "Releasees"), with respect to all and any injury, disability, death, or loss or damage to person or property whether arising from the negligence of the Releasees or otherwise, to the fullest extent permitted by law.
